Call to Order

With a quorum present, Chair Dr. Todd Ivan called the meeting to order at 5:33pm

Swearing in of Jack Diamond by the Honorable Judge Jennifer Towell

- Dr. Ivan began the meeting by asking Jack Diamond to join the Honorable Judge Jennifer Towell to be sworn in as a member of the ADM Board of Directors.
- After being formally sworn in, Judge Jennifer Towell congratulated Jack Diamond as the newest member of the Summit County ADM Board of Directors.

Board Education

A. Alliance for Healthy Youth Overview - Cheryl Biddle, Founder & Executive Director; Beth Ann Rasey, Youth Development Coordinator

- Cheryl Biddle gave a presentation to the board about Alliance for Healthy (AHY) Youth's CATS Program (Concerned About Teen Success). This program began in 1987 and they have had over 3000 high school students volunteer for this program since its inception, and they are present in 23 schools across Summit County.
- Ms. Biddle also invited an AHY staff member and CATS student to present to the board of directors.

Ownership & Linkage & Accountability

A. Chair Report - Dr. Todd Ivan

- Chair Dr. Todd Ivan announced that the Board of Directors will be meeting offsite at ARC Recovery Services on April 23rd. Calendar invites will be updated with the meeting and location details.
- Chair Ivan also announced that the Ohio 2024 Mental Health and Addiction Conference will be held at the Hyatt Regency in Columbus on June 3-4, 2024. Board members interested in attending the Ohio 2024 Mental Health and Addiction Conference were encouraged to let Director Wade know by April 1st.

B. Executive Director Report - Aimee Wade

 Director Wade recognized 2 ADM Staff members for their employment anniversaries; Holly Cundiff is celebrating her 5 year anniversary and Tom Mino is celebrating 25 years with the ADM Board.

- Director Wade Also noted the launch of the Summit County Outreach Team (SCOUT) and provided links to media coverage.
- Director Wade provided an update on her invitation to attend the Congressional Black Caucus Foundation's (CBCF) Sojourner Truth's Legacy project to participate on a panel in Washington DC to discuss physical and mental health care disparities for women. It was a very impactful event, and Director Wade expressed appreciation to the CBCF and Congresswoman Emilia Sykes for the invitation and the opportunity to represent the ADM Board, Summit County and Ohio's 13th district.

C. Chief Clinical Officer Report - Dr. Doug Smith

• Dr. Smith informed the board that SCOUT has exceeded our expectations. We are in our fourth week since the press conference, and the team has already gone out on 60 different calls. They are working in collaboration with 911 and 988 and things are going very smoothly. It was also noted that if the team does not have an active call, they can follow up with residents they've seen before.

Comments from Public and Announcements

Amy Woodland provided each board member with a sponsorship packet for the recovery challenge and a list of all upcoming events for the rest of 2024. Ms. Woodland will also be electronically sending individual pledge cards to the board within the next week.

Keri Deyling from Coleman Health Services announced that they are hosting Unmute the Uncomfortable, a Racial Equity, Mental Health Awareness, and Suicide Prevention event on Thursday, May 9th at House 330. The topic this year is mental health focused on how it impacts the black and brown male community.

Committee Reports

A. Governance Committee - Charles Twigg, Committee Member

- Charles Twigg provided the Governance Committee report this month. He noted that 3 board members are rolling off in June 2024. 2 of these individuals are Ohio Mental Health and Addiction Services (OMHAS) appointments, and one is a county executive appointment. However, due to a change in state law, one of the OMHAS seats will switch to a county executive seat starting July 1st.
- Mr. Twigg continued that this committee also discussed strategic planning and noted that there are two proposals for the board to review in their meeting books.
- The funding for the proposal were included in the funding awards list for approval.

• After some brief discussion, Mr. Twigg read the motion cast by the Governance Committee to increase the BoD's budget to accommodate for the proposals and planning.

- Mr. Twigg continued that this committee discussed virtual meeting access but tabled this discussion to continue to monitor state legislation.
- The Governance Committee also discussed board committee structure, noting that they are working to increase engagement. They decided to add this piece to the strategic planning process.
- Mr. Twigg concluded this report announcing to the board that the committee reviewed the 2024 Demographics Survey. This survey will be sent out by the end of March.
- It was also noted that the board will receive a doodle poll to determine availability for their upcoming board retreat.
