D. 2025 Govern for Impact Conference

• Two SC ADM Board of Directors Members and two ADM Staff attended the 2025 Governance for Impact Conference. Executive Director Wade and Ms. Curley both gave key takeaways from the conference. Executive Director Wade emphasized that the conference offered networking opportunities, education, and additional resources for more effective and efficient monitoring, engagement, training, and governance. The focus shifted this year more on the principles of the Policy Governance model and best practices. Next years conference is June 11th, 2026 - June 13th, 2026.

E. 2025 Board Education & Annual In-Service Training

 Executive Director Wade provided the committee with draft agendas for the annual board education and in-service training. Director Cornyn from the Ohio Department of Mental Health & Addiction Services attendance is confirmed for this event. There was dialogue amongst the committee and ADM Board staff and members
Johnson and Shannon agreed to help plan out portions of the agenda.

A. Annual Review of Board Process and Board Management Connection Policies

- The Committee reviewed Policy 3.2 and found no recommended changes.
- There is still one outstanding Receipt of Ohio Ethics Law Statement and Conflict of Interest Annual Statement of Disclosure that has not been submitted. The committee recommended that Chair Myers follow up with the BoD member.

2. Policy 4.3 Delegation to the Executive Director

• The committee reviewed Policy 4.3 and found no recommended changes.

B. Board Performance
